Apology Bill. (U.S. Public Law 103-150 – 107 Stat. 1510) admits the invasion, overthrow, occupation, and annexation of 1893 violated diplomatic treaties, international law, Laws of Nations, and the United States Constitution. Under International law the World Court ruled the only appropriate remedy is restitution. That fact gives absolute right and power to restore independence. The U.S. Congress has no power, jurisdiction or authority to stop the restoration of the Kingdom. The United Nations Charter states: An autonomous independent sovereign nation-state contemplated under Article 1 of the Montevideo Convention on Rights and Duties of States requiring the state as a person of international law possessing the four qualifications of (a) a permanent population, (b) a defined territory, (c) government; and (d) capacity to enter into relations with the other states. Subject: Mauna a Wakea

Aloha mai e Kiaaina Ige, Luna Nui Kim a me Mr. Lassner,

I open my letter with my Cousin, Her Royal Majesty, Queen Liliʻuokalani (1898) ...

“Oh, honest Americans, as Christians hear me for my downtrodden people! Their form of government is as dear to them as yours is as precious to you. Quite warmly as you love your country, so they love theirs. With all your goodly possessions, covering a territory so immense that there yet remain parts

The people to whom your fathers told of the living God, and taught to call "Father," and whom the sons now seek to despoil and destroy, are crying aloud to Him in their time of trouble; and He will keep His promise and will listen to the voices of His Hawaiian children lamenting for their homes."

The time has come.

In Kapu Aloha, I am armed with the absolute knowledge that I am speaking to the illegal occupiers of the Kingdom of Hawai'i. Colonizers, with no respect for spiritual ancestral knowledge, and indigenous cultural and Hawaiian traditional life that has sustained us since time immemorial.

Facts in evidence:

The Kingdom was stolen and that continuous theft lingers till this day. It's only a matter of time when you, the Colonizers will leave these Hawaiian Islands, as justice will prevail.

2 years ago, the Dakota Access pipeline (DAPL) saw 300 water protectors injured after police used water cannons and other weapons against Peaceful Opposition seeking to protect Water from being contaminated by oil. Twenty-six protectors were hospitalized and more than 300 injured after North Dakota law enforcement attacked First Nation peoples, environmentalists, traditional cultural practitioners and sacred holy men protesting the Dakota Access pipeline. These violent acts perpetrated against unarmed peaceful people were Unconscionable. Laws were quickly manufactured to support the building of the pipeline and to bring in National Guards and Law Enforcement to enforce the rule of laws created to pave the way for the DAPL pipeline project. Essentially unconstitutional laws were passed to make protest illegal and to legalize acts that would otherwise be illegal.

The Standing Rock Medic & Healer Council said injuries from the “mass casualty incident” included multiple bone fractures from projectiles fired by police, a man with internal bleeding injured from a rubber bullet, a man who suffered a grand mal seizure, and a woman who was struck in the face with a rubber bullet that resulted in the loss of one eye.

Protector Sophie Wilansky, 21 years old, almost lost her arm when struck by an exploding flash bang grenade.

Filmmaker Shannon Kring approximately 42 years of age, was healthy prior to filming <http://www.endofthelinefilm.com/> at Standing Rock. Approximately, 2 years later she was diagnosed with the following: Crohn’s disease, Rheumatoid Arthritis, Lupus, and Mixed Connective Tissue Disease.

Lakota Water Protector, Waste Win Young approximately 38 years of age, was healthy prior to Standing Rock. She was one of the original 4 water protectors to establish camp and was there for the duration. Approximately, 2 years later, Waste Win was diagnosed with the following: Mixed Connective Tissue Disease, Polymyositis, Rheumatoid Arthritis and Bursitis.

Respiratory issues, lingering coughs, insomnia, unexplained weight gain, feelings of heightened aggression and depression were wide spread symptoms after the water cannon attacks, tasers, rubber bullets, LRAD frequencies, et al. were unleashed on the unarmed Water Protectors.

Concerns:

Gentlemen, it has been well publicized that ‘Your’ Law Enforcement Officers are going to use similar supposed non-lethal weapons against the Protectors of Mauna a Wakea. We know from the experiences at Standing Rock that these weapons and tainted water from water cannons are lethal and can cause irreparable short term and long-term damage to the body, mind and spirit. Should these weapons be deployed, those attacked would include Kupuna’s from ages 65 to 90 years and our children, the future leaders of the Kingdom of Hawai’i.

These weaponries are unjustified and unconscionable. They cannot be used against my People. To use them would be an Act of War that will galvanize the Nations of the world, many of whom have a profound love and respect for me and the Kingdom of Hawai’i.
