Apology Bill. (U.S. Public Law 103-150 – 107 Stat. 1510) admits the invasion, overthrow, occupation, and annexation of 1893 violated diplomatic treaties, international law, Laws of Nations, and the United States Constitution. Under International law the World Court ruled the only appropriate remedy is restitution. That fact gives absolute right and power to restore independence. The U.S. Congress has no power, jurisdiction or authority to stop the restoration of the Kingdom. The United Nations Charter states: An autonomous independent sovereign nation-state contemplated under Article 1 of the Montevideo Convention on Rights and Duties of States requiring the state as a person of international law possessing the four qualifications of (a) a permanent population, (b) a defined territory, (c) government; and (d) capacity to enter into relations with the other states. If what I am hearing from my Intelligence officers are true, hopefully this message from me will preempt any possible irresponsible actions being ordered by all of you that violates Your Constitutional doctrines as well as the rights of the people to live in a society free from tyranny and oppression. In this scenario, the Hawai'i State Supreme Court and your high offices would be using the police as your personal Gestapo to force the people into subservience as your slaves. This is not only unconscionable but unconstitutional.

Culture and society are intricately related. A culture consists of the "objects" of a society, while a society consists of people who share a common culture.

The People on the Mauna are the Descendants of these lands we call and love – Hawai'i. The 'Aina is an integral part of who 'we' are as an enlightened Society which has lived for over 2,000 years.



In this case, the 'Rule of Law' is to protect 'Society' from foreign and domestic violence. Again, should your actions against my people be carried out, it would be paramount to Domestic Terroristic Violence against those practicing Kapu Aloha in the most dignified way. This would only demonstrate the terroristic nature of enacting your inhumane policies.

Seizing private property, disrupting a gathering protected by the First Amendment to the United States Constitution (assembly seeking redress of grievances, free speech, freedom of religious practice), ignoring the legitimate claims of the restored Kingdom, bringing in foreign law enforcement because people of the islands are not willing to terrorize their own people -- these are all the actions of a discredited government unwilling to listen to the people it supposedly serves.

Mayor Kim, of course the Governor and the Attorney General will provide you with "legal cover" for what you intend to do. Their phony excuses citing public health and safety concerns is a lie. Based on your statements regarding an earlier visit to the Mauna, you reported a peaceful, well organized gathering. The cover lies provided to you will not make your actions pono.

There is peace on the Mauna right now. Breaking that peace will be your legacy as Mayor. You clearly are pursuing a path towards confrontation that will only be neutralized by the love expressed as *Kapu Aloha!* You should consider the true meaning of *Heva because that will be what you bring to our community and what you will bring into your own life.*
